Influenza vaccination - questions and answers



From when will the vaccinations be performed at LUX MED facilities?

Vaccinations are planned to start in the first half of September.



When can appointments be booked?

Vaccinations are planned to start in the first half of September. The exact start date will be published on our website at www.luxmed.pl.



Influenza vaccination - questions and answers



During what period will the vaccinations be performed?

Vaccinations will be performed from September 2024 to the end of March 2025 or until exhaustion of stocks.



Can eligibility for vaccination be performed during a phone consultation?

No. Eligibility for influenza vaccination will be performed during on-site consultations so that the Patient is vaccinated directly after positive eligibility assessment.



Influenza vaccination - questions and answers



Who will be eligible for vaccination?

Children under 15 years of age. Eligibility assessments will be made by a paediatrician. Adolescents between 16 and 17 years of age. Eligibility assessments will be made by a general practitioner/family physician. Adults – eligibility assessments for influenza vaccinations may be made by Nurses, Midwives or Paramedics.



How many doses of influenza vaccine will be administered?

Children between 6 months and 8 years of age that will be vaccinated against influenza for the first time need to receive two doses of influenza vaccine with at least 4 weeks between doses. Children under the age of 8 that will be vaccinated against influenza once again, children over the age of 8 and adults receive one dose of influenza vaccine.

Will there be a possibility to get vaccinated with my own product?

It is not possible at this point.



Can I get a refund for the vaccine I bought?

Due to the fact that vaccines will be available at LUX MED Group facilities, we do not provide reimbursement for purchased vaccines.

Will vaccinations be performed at all your facilities or just at selected sites - and if selected - at which ones?

Vaccinations will be performed at all facilities.



Will vaccinations also be available at subcontractor facilities?

The vaccinations will also be performed at subcontractor facilities.



Influenza vaccination - questions and answers



Will vaccinations be performed at all subcontractor facilities?

Vaccinations at subcontractor facilities depend on the availability of the product at a given facility.



Can flu and COVID-19 preparations be combined? What interval should be kept between the preparations?

According to the statement of the National Institute for Public Health based on experience in the implementation of the Vaccination Programme against COVID-19, experts have mitigated the initial recommendations on combining both products. The vaccine can be administered at any time after the receipt of the COVID-19 vaccine. It should be noted that the final decision on vaccination with multiple preparations is made by the personnel making the eligibility assessment.

What preparations will be available?

This year there is two injectable vaccine, VAXIGRIP Tetra and INFLUVAC Tetra.



Will I have a chance to get vaccinated if I do not have an insurance package?

Yes, we also provide vaccinations for a fee.

Will it be possible to register a group of Employees for vaccination at a facility?

Patients whose subscription covers flu vaccination will be able to arrange for an eligibility visit and administration of the vaccine via the Patient Portal or the Phone Line. This year, we do not plan to organise vaccinations for groups at medical centres, but we perform vaccinations at the Client's premises.



Will vaccinations also be performed at the Client's premises?

Yes, vaccinations will also be performed at the Client's premises.

What is the minimum number of individuals necessary to perform vaccinations at a Client's premises?

The minimum number of people for vaccinations is 30.



Is it possible to register family members for outpatient vaccinations at the Client's premises?

Yes, family members can apply for vaccinations. Vaccinations performed outside the facility are available for individuals aged over 18.
